Noise from music, performances and or speeches should not be audible within noise sensitive premises with the windows of these premises open.

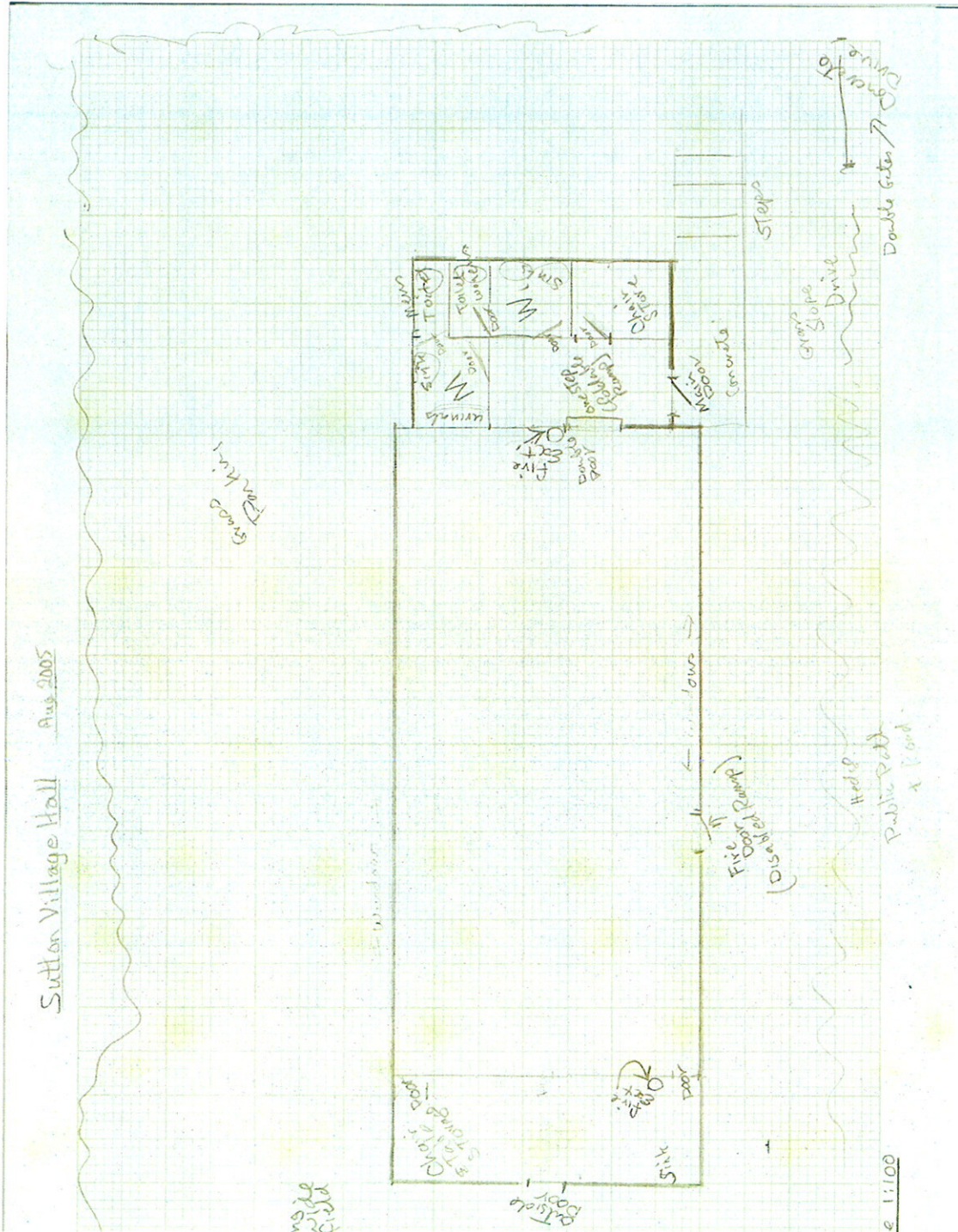
All external doors and windows must be kept closed whilst a public entertainment event is in progress.
